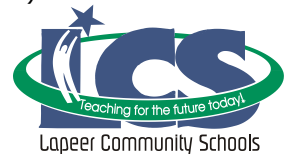

Dear Parent/Guardian:

On March 1, the Board of Education approved the repurposing of Turrill Elementary as a Year-Round Elementary School as part of a comprehensive district-wide restructuring plan. As part of the plan, two elementary buildings (Seaton and Maple Grove) also have been slated for closure at the end of the school year.

As a result of these changes, in mid-April new elementary attendance boundaries will be created and mailed directly to every elementary family in the District. To be clear, this means that the school your child(ren) is (are) currently attending may be changing.



- The only exception is that regardless of where new attendance boundaries lie, 4th grade students and their siblings will be allowed to remain in the building they currently attend. However, transportation will not be provided for 4<sup>th</sup> grade students and their siblings who remain in their current building but do not reside in the new attendance area.
- An elementary school of choice window will also be opened when new attendance boundaries are determined. All students who currently attend an LCS building through a schools of choice program will need to re-apply at that time.
- Previously approved out-of-district students will remain approved to the Lapeer District but will need to apply for specific building assignment. Applications will be due no later than April 27.

If you would like your child to have the opportunity to attend the Year-Round School at Turrill Elementary, you must complete and return the enclosed application by March 16. If the number of applicants exceeds the building capacity, a lottery system will be used to select students who will attend.

All parents will be notified of the status of applications the week of March 26.

The Year-Round School, starting August 1, will operate on a balanced academic calendar. Transportation will be provided for all students attending the Year-Round School. The benefits of a balanced calendar, including the closing of the "summer gap" in student retention, have been well-established through numerous studies. For Lapeer Community Schools, this new approach represents an option to families in the District.

In addition to the changes previously described, for Fall 2012 we will implement a full, five-day Kindergarten program. Parents may register for Kindergarten at Round-up on April 17-18 at the Administration & Services Center from 1-7 p.m. on both days. Kindergarten students will be able to apply for Year-Round School at that time.

As a community, we are excited to be able to offer these new opportunities to elementary families across the District.
